TERMS & CONDITIONS – PET SITTING SERVICES

1. JR Doberman Crew, LLC agrees to provide reasonable care, feeding, exercise, and supervision as outlined in this agreement.
2. JR Doberman Crew, LLC is not a veterinary facility and does not provide medical care.
3. Client authorizes JR Doberman Crew, LLC to seek emergency veterinary care if deemed necessary. All veterinary expenses shall be the responsibility of the Client.
4. Client agrees to fully disclose any history of aggression, biting, escape behavior, anxiety, or medical conditions prior to the start of services.
5. Personal items (including toys, bedding, collars, leashes, and food) left with their Pet are provided at the Client's own risk.
6. Client certifies their Pet is in good health and current on all required vaccinations and preventative care at the time services begin.
7. If medication or special care is required, Client must provide clear written instructions. JR Doberman Crew, LLC is not responsible for complications arising from undisclosed conditions or unclear instructions.
8. Client understands their Pet may behave differently in new environments and agrees JR

resulting from pre-existing conditions, undisclosed behaviors, or circumstances beyond reasonable control.

9. Client agrees to assume full responsibility for any damage or injury caused by their Pet to people, property, or other animals during the service period.
10. Client must provide an emergency contact other than themselves who are authorized to make decisions if the Client cannot be reached.
11. JR Doberman Crew, LLC reserves the right to refuse or discontinue services at any time if their Pet poses a safety risk to staff, other animals, or itself.
12. Additional fees may apply for extended stays, special care, or failure to pick up their Pet at the agreed-upon time.
13. Client grants permission for photos or videos of their Pet to be taken for updates and promotional use unless otherwise stated in writing.

CANCELLATION POLICY

Client may cancel services without penalty with proper notice:

- Training: at least 7 days prior to the scheduled session
- Boarding: at least 14 days prior to the scheduled stay

Cancellations made after these timeframes will be subject to a 40% cancellation fee of the total training cost or boarding stay.
