TERMS & CONDITIONS – PET TRAINING & BOARDING/TRAINING SERVICES

1. Client agrees that JR Doberman Crew, LLC will provide reasonable care, supervision, feeding, exercise, and structured training consistent with the selected Pet Training or Boarding & Training program.
2. Client agrees and understands that training results vary by Pet based on temperament, age, prior training, consistency, and environment, and that no guarantees are made regarding specific training outcomes or behavioral changes.

3. Client agrees that JR Doberman Crew, LLC is not a veterinary facility and does not provide medical treatment.
4. Client agrees to authorize JR Doberman Crew, LLC to seek emergency veterinary care if deemed necessary for the Pet's health or safety, and further agrees that all veterinary expenses, including transportation and treatment, are the sole responsibility of the Client.
5. Client agrees to fully disclose any history of aggression, biting, resource guarding, escape behavior, anxiety, fear responses, or medical conditions prior to the start of training or boarding services.
6. Client agrees that any personal items provided (including toys, bedding, collars, leashes, crates, or food) are left at the Client's own risk, and JR Doberman Crew, LLC shall not be responsible for loss or damage to personal property.
7. Client agrees and certifies that their Pet is in good health, free from contagious illness, and current on all required vaccinations and preventative care at the time services begin.
8. Client agrees that if medication or special care is required, they will provide written instructions and all necessary supplies, and that JR Doberman Crew, LLC is not responsible for complications arising from undisclosed conditions, incorrect information, or unclear instructions.

9. Client agrees and acknowledges that Pets may behave differently in new environments or during training, and that JR Doberman Crew, LLC shall not be held liable for illness, injury, escape, loss, or death resulting from pre-existing conditions, undisclosed behaviors, stress-related responses, or circumstances beyond reasonable control.
10. Client agrees to assume full responsibility for any injury or damage caused by their Pet to people, property, equipment, or other animals during the training or boarding period.
11. Client agrees to provide an emergency contact other than themselves who is authorized to make decisions on their behalf if the Client cannot be reached.
12. Client agrees that JR Doberman Crew, LLC reserves the right to refuse or discontinue training or boarding services at any time if the Pet poses a safety risk to staff, other animals, or itself, and understands that refunds are not guaranteed in such cases.
13. Client agrees that additional fees may apply for extended stays, specialized training needs, behavioral management, medical care coordination, or failure to pick up the Pet at the agreed-upon time.
14. Client agrees to grant permission for photos or videos of their Pet to be taken for training updates and promotional purposes unless otherwise stated in writing prior to services.

CANCELLATION POLICY

Clients may cancel services without penalty with proper notice:

- Training: at least 7 days prior to the scheduled session
- Boarding: at least 14 days prior to the scheduled stay

Cancellations made after these timeframes will be subject to a 40% cancellation fee of the total training cost or boarding stay.
